## Special Agent Michael T. Walter

On May 26, 2017, the Department mourned the loss its 63rd line of duty death. Special Agent Michael T. Walter, who was assigned to the BCI Richmond Field Office's Drug Enforcement Section, was engaged in a conversation with two individuals in the City of Richmond. One of those two men shot Special Agent Walter and then fled the scene on foot. The shooter was apprehended the next day in the Northern Neck. Special Agent Walter succumbed to his injuries. The 45 year old Philadelphia native and decorated veteran of the United States Marine Corps (USMC) joined state police in 1998 as a member of the 98th Basic Session.

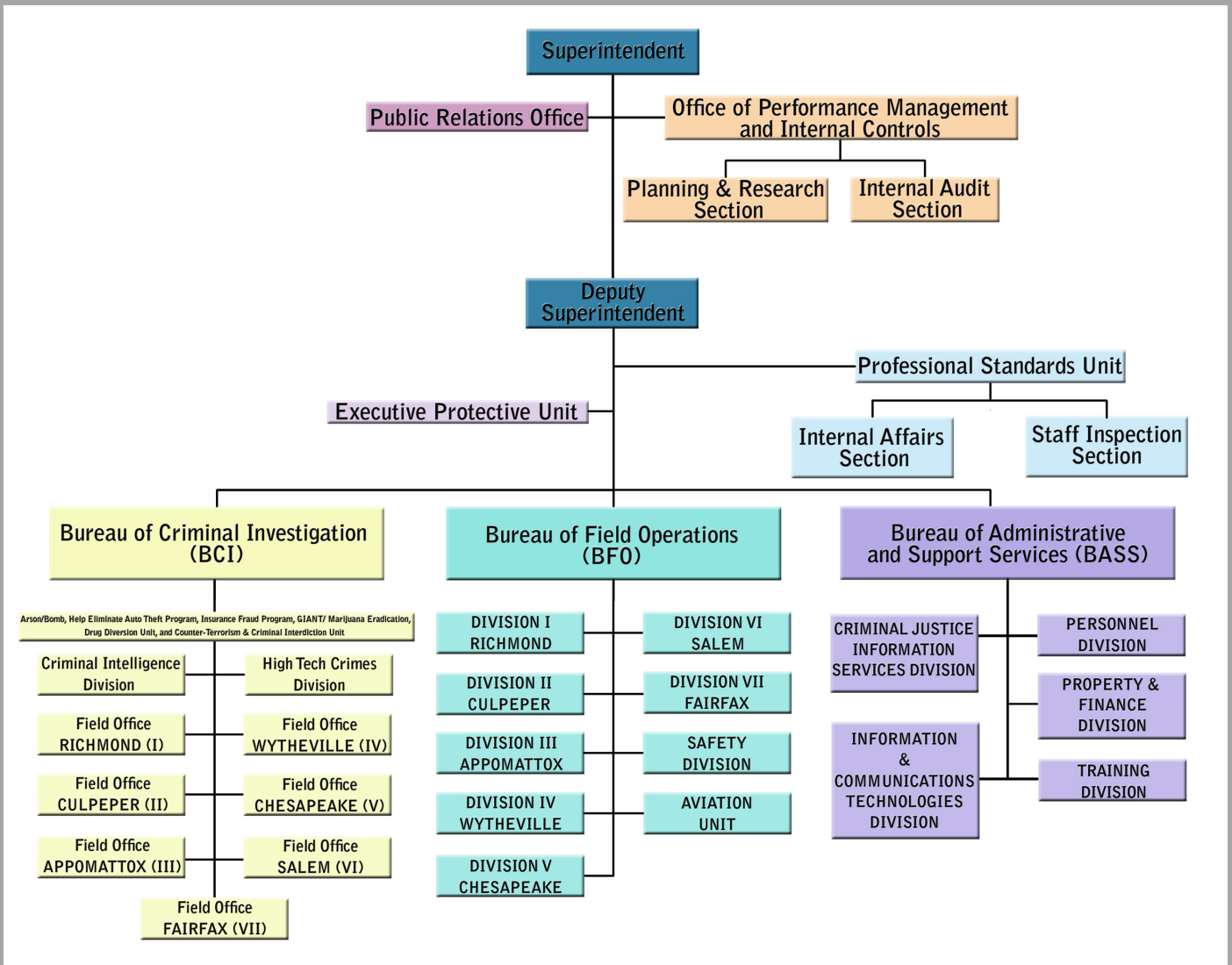
## Lt. H. Jay Cullen, III Trooper-Pilot Berke M.M. Bates

Lt. H. Jay Cullen and Trooper Pilot Berke M.M. Bates were providing aerial support to the Governor's detail on the afternoon of August 12, 2017, when their Bell 407 helicopter crashed into a wooded area of Albemarle County. The Governor had arrived in Charlottesville to attend a press conference following the Unite the Right Rally and multi casualty pedestrian traffic crash earlier that same day.

Lt. Cullen, 48, was the commander of the Aviation Unit and had joined the Department in 1994 as a member of the 90th Basic Session. A native of New York, he was a graduate of Emory Riddle Aeronautical University.

Trooper Pilot Bates, 39, had served with the Florida Highway Patrol before joining the Virginia State Police in 2004 as a member of the 107th Basic Session. The Manassas, Va. native had just transferred to the Aviation Unit in July from the BCI Richmond Field Office's General Investigations Section.

# SUPERINTENDENT'S OFFICE

## EXECUTIVE PROTECTIVE UNIT (EPU)

The plainclothes troopers assigned to the Executive Protective Unit (EPU) provide 24-hour security for Governor Terry McAuliffe and his family. EPU coordinates the Governor's schedule, secures routes for his upcoming appearances and events and works with local, federal and law enforcement agencies from other states when traveling to ensure maximum security and effectiveness of the detail.

## PUBLIC RELATIONS OFFICE (PRO)

The Public Relations Office is responsible for the development and implementation of comprehensive, proactive public and media relations information and outreach regarding traffic safety, crime prevention and criminal investigations. The PRO attracted several thousand new "followers" in 2017 to the VSP Facebook and Twitter pages. The civilian PRO staff works closely with the field Public Information Officer (PIO) sergeants and produced 26 statewide press releases in 2017 and fulfilled more than 1,000 media inquiries. The PRO also provides assistance to local sheriffs and police departments with major incidents, as well as the offices of the Governor and the Secretary of Public Safety and Homeland Security. The PRO also worked closely with the City of Charlottesville in preparation for and during the 2017 Unite the Right Rally.



# SUPERINTENDENT'S OFFICE

## YOUTH OF VIRGINIA SPEAK OUT ABOUT TRAFFIC SAFETY (YOVASO)

A statewide, peer-to-peer advocacy program that engages, educates and empowers Virginia's youth to influence a safe driving culture through leadership development and innovative outreach programs. Its vision is to establish generations of safe teen drivers in Virginia. In 2014, VSP absorbed the federally-funded grant program, which was established in 2001 by the Blue Ridge Transportation Safety Board and the Virginia DMV Highway Safety Office.

In 2017, seven new YOVASO programs were established at schools in the counties of Chesterfield and Smyth and in the cities of Staunton and Norfolk. The program also hosted its annual Summer Leadership Retreat in June.

YOVASO, with a staff of 3 full-time civilians and part-time youth advisors, currently has 106 member schools and youth organizations.

# SUPERINTENDENT'S OFFICE

## OFFICE OF PERFORMANCE MANAGEMENT & INTERNAL CONTROLS (OPMIC)

OPMIC tracks, monitors and guides the Department's progress towards achieving and sustaining agency and state government objectives and strategies.

**Information Security Office:** Ensures data security for all types of sensitive information within the Department's purview. The safeguarding of this data within the Department's operational and highly mobile environment is its primary goal.

**Internal Audit Section:** Performs audits and reviews of Department operations for the purpose of monitoring the agency's performance. Four audits were initiated in 2017, three of which were completed and a fourth that was completed in 2018. This section works to maximize the efficiency and effectiveness of Department operations and strengthen internal controls. This section routinely reviews financial data and reporting mechanisms, regulation and policy compliance, asset safeguards, loss detection and prevention, and technology data system security.

**Staff Inspection Section:** Conducts inspections of all VSP organizational components, ensuring compliance with accreditation standards, regulatory requirements and Department policies and procedures. Six staff inspections were conducted in 2017 for the Bureau of Criminal Investigation (BCI) and Bureau of Field Operations (BFO) Chesapeake and Richmond Divisions, Aviation Unit, Safety Division, Criminal Intelligence Division and the Information and Communications Technologies Division. The Staff Inspection Section also manages all agency records retention and destruction within and ensures continuous agency-wide compliance with the applicable standards necessary to remain nationally accredited by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA).

90.1% of citizens surveyed in 2017 rated VSP's service delivery as "very good" or "excellent."

94% said they were treated fairly by VSP personnel.

# SUPERINTENDENT'S OFFICE

**Strategic Development Section:** Supports Department divisions and units through equipment studies, program development, research projects, technology evaluations, staffing formula updates, legislative studies and grant management. In 2017, this section administered 45 grant projects worth approximately \$22 million in support of essential Department projects and programs. The section also responded to 224 requests for information from criminal justice agencies and academic research centers nationwide.

## OFFICE OF INTERNAL AFFAIRS (IA)

Initiates and conducts administrative investigations concerning allegations of misconduct on the part of VSP personnel. The office also investigates complaint referrals reported through the State Employee Fraud, Waste and Abuse Hotline. In 2017, IA processed 394 investigations, to include two biased-policing complaints. One of those cases (discrimination) was sustained; the other complaint (racial profiling) was unfounded.

# BUREAU OF ADMINISTRATIVE & SUPPORT SERVICES (BASS)

Provides vital professional support and technical expertise to not only VSP, but also to local, state and federal law enforcement agencies, the state judicial system and the general public. Its role is essential to the successful continuity of a multitude of services throughout its field divisions and offices.

## INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

Manages the symbiotic relationship between the ever-evolving environments of the Department's unique and diversified digital, computer and communications technologies. The ICTD, which is divided into a Communications Section and Information Technologies Section, provides the Department with a global view and unified management of existing and future IT and communications projects.

## COMMUNICATIONS SECTION

**Statewide Agencies Radio System (STARS):** One of the first statewide systems in the nation to employ P25 standardized digital trunked technology in the VHF150 MHz band. Composed of VSP and 21 state agencies that use two-way radio communications and mobile data for public safety and service as part of their operational needs, it was also one of the first projects to employ an integrated voice and data land mobile radio architecture, which uses the same mobile radio for both voice and law enforcement mobile data communications.

The 209 STARS communications sites include:

- 9 legacy sites
- 17 microwave-only sites
- 23 dispatch centers
- 67 contain STARS land-mobile radios
- 78 VSP Area Offices



# INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

## COMMUNICATIONS SECTION

**Commonwealth Link to Interoperable Communications (COMLINC):** Provides design, engineering, maintenance and tech support for the 172 COMLINC sites statewide. Since its inception in 2010, this essential network consolidates the efforts of several regions of Virginia to provide interoperability between VSP with/among 116 out of 134 localities, as well as other state and federal agencies.

**Computer-Aided Dispatch (CAD):** Allows for rapid entry and retrieval of data-related officer activity and calls for service. CAD supports over 70 dispatch workstations between VSP's seven division Dispatch Centers, as well 100 remote-access users and command post/remote location dispatching terminals used during significant events and critical incidents. In 2017, more than 1.9-million CAD events were generated and recorded by VSP personnel.

- **CAD Management Information System (MIS):** Central repository database for all seven field division CAD systems. It currently holds 20-million records and enables VSP instant access to calls for service, unit activities, call trends, manpower utilization, response times and disaster-related incidents.



**Mobile Server System (MSS):** Supports 2,500 mobile data terminal (MDT) users and mobile CAD software users from VSP, other state agencies and local law enforcement. MSS interfaces between the MDTs and CAD ensuring full mobile CAD functionality and access to the Virginia Criminal Information Network (VCIN) and DMV records. It also serves as the central interface between CAD, VDOT and the Virginia Fusion Center.

**Next Generation Camera System Pilot:** VSP initiated its transition from a DVD, single-camera system to a multi-camera, digital technology with four networked cameras (forward; panoramic; infrared in-cabin; and body-worn. Testing continues related to offloading video via Wi-Fi to a local server at the test Area Office.

Communications Section designs, installs, operates, maintains and supports VSP:

- Land Mobile Radio (LMR) Network
- Patrol-Vehicle Mobile Data Terminals (MDT)
- Microwave Radio Network
- Integrated Flood Warning Systems
- Telephone Network
- 1,794 RADAR and 620 LIDAR Speed-Determination Equipment and Calibration
- Wireless Radio Communications
- Radio Communications Towers
- Network Operations Center (NOC)
- Vehicle Maintenance and Emergency Equipment Installations

Communications Section is responsible for ensuring all VSP-related communications systems and networks are FCC, FAA and EPA compliant. The section actively participates in the Capital Wireless Interoperability Network (CAPWIN) and SAFECOM.

# INFORMATION & COMMUNICATIONS TECHNOLOGIES DIVISION (ICTD)

## INFORMATION TECHNOLOGY (IT) SECTION

### **Asset and Inventory Management System (AIMS):**

Work initiated in 2016 to migrate the Material Management System into AIMS continued in 2017. AIMS retires VSP's legacy MAPPER applications related to asset management.

### **Computerized Criminal History (CCH):**

Twenty nightly, weekly, monthly and quarterly "batch processes" rewritten and moved to a new application server, thus providing enhanced stability and better use of VSP resources for licensing. 2017 also saw continuing work on application improvements to enhance functionality and stability.

### **Consolidated Applicant Tracking System (CATS):**

The IT Section and VSP Criminal Justice Information Services (CJIS) Division established a team to identify necessary enhancements and corrections within CATS. The team is working towards completing 15 recommended improvements.

**Data Warehouse:** Created and established nightly data loads from production transaction systems, as well as published data reports for VSP bureaus and divisions. Work continues to expand the warehouse's physical footprint and to add more transactional data from other production systems.

**eVA Procurement:** Integration of Virginia's electronic procurement system (eVA) and VSP's Accounts Payable and General Ledger began in 2017. Full integration will save the Property and Finance Division significant time and aid VSP with meeting payment obligations in a timely manner.

**Evidence Management System (EMS):** Initiated in 2016, EMS was successfully piloted in 2017. Roll out of the system to all seven field divisions will begin in 2018.

### **Firearms Transaction Center (FTC) System:**

Significant enhancements to the system began in 2017 that enabled certain federally-licensed firearms dealers to complete application forms for firearm purchases online. Full implementation will take place in 2018.

**Incident Based Reporting (IBR):** Work was initiated to implement a new IBR system and transition to a cloud-based vendor from the legacy COBOL IBR.

### **Law Enforcement Activity Management System (LEAMS):**

Incident reporting policies and procedures were updated and published along with more than 50 additional improvements made in 2017. Revised and additional training were provided to troopers and sergeants.

### **Motor Vehicle Inspection Program (MVIP):**

Integration with CARFAX completed for data exchange and monthly billing practices.

### INFORMATION TECHNOLOGY (IT) SECTION

**Oracle eBusiness Suite for Human Resources (OEBS):** A new team was formed in partnership with the Personnel Division to implement OEBS with Phase I to be initiated in 2018. Upon completion, OEBS will replace and retire the legacy MAPPER HR system.

**Sex Offender and Crimes Against Minors Registry (SOR):** Project initiated to replace the existing, 18-year-old SOR with a modern, more capable online system. Vendor solicitation and selection should be completed by 2019.

The Information Section is responsible for implementation and maintenance of other mission-critical applications and infrastructure that support local, state and federal law enforcement agencies and the general public:

- Virginia AMBER Alert
- Virginia Senior Alert
- Virginia Blue Alert

## CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

Collects, stores and retrieves critical law enforcement data for use by local, state and federal criminal justice agencies, non-criminal justice government agencies, private employers and firearms dealers operating in compliance with state and federal law and policies.

**Automated Fingerprint Identification System (AFIS):** Searches and stores rolled fingerprints and palm prints from criminal arrests, convicted sex offenders and partial latent fingerprints recovered from crime scenes across the Commonwealth. VSP and 24 other state and local law enforcement agencies have AFIS access through terminals located at the respective agencies. The Integra-ID database receives Live Scan fingerprint transmissions and provides automated interfaces to combined criminal history systems, Consolidated Applicant Tracking System (CATS) and AFIS for the purpose of criminal history record searches or latent fingerprint matches.

**Expungement Section:** Tasked with processing petitions for expungement and court-ordered expungements of criminal history information. In 2017, the section received more than 4,226 petitions and court orders, which represents a 6% increase in comparison to 2016. The section also completes quarterly Interstate Identification Index (III) audits and processing criminal record challenge requests.

# CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Central Criminal Records Exchange (CCRE):** Established more than 50 years ago, the CCRE is nationally recognized as a leader in maintaining a comprehensive criminal record database, including the development of state-of-the-art programs to deliver the most complete and accurate criminal records information and automated support programs. CCRE conducts criminal and non-criminal record searches, depending on an agency's, law enforcement officer's or individual's need or as mandated by state law.

# CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

**Firearms Transaction Center (FTC):** The first of its type in the nation when established in 1989, the FTC has been cited as an exemplary program and used as a model for other states. The FTC provides Virginia-based Federal Firearms Licensed (FFL) dealers with instantaneous confirmation of a prospective purchaser's eligibility to purchase a firearm. All appropriate state databases and the National Instant Check System (NICS) are accessed as part of the point-of-sale, criminal history record information check approval process for purchase of all firearms, except antiques and curios. FTC transactions are accomplished through V-Check, an Internet-based instant background check program. In 2017, approximately 95% of all transactions, statewide, were processed through V-Check.

# CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

---

**Sex Offender and Crimes Against Minors Registry (SOR):** One of the nation's most comprehensive public sex offender registries in the nation, the Virginia SOR is designed to protect the general public, with children in particular, by providing personal descriptive, employment and sentencing information on individuals who have been convicted of certain sex crimes and are currently living/working in the Commonwealth. Access to this information and the SOR website is provided free of charge to the public.

**Sex Offender Investigative Unit (SOIU):** Conducts on-site verifications of all residential and employer addresses of registered, convicted sex offenders. The SOIU, which is composed of troopers and civilian compliance officers, conducts criminal investigations related to offenders who fail to comply with SOR registration requirements. Through the Sex Offender Verification System (SOV), the SOIU works closely with local law enforcement, the U.S. Marshals Service and the Virginia Department of Corrections (VDOC) Probation and Parole.

# CRIMINAL JUSTICE INFORMATION SERVICES DIVISION (CJIS)

---

**Uniform Crime/Incident Based Reporting (UCR/IBR) Section):** Collects monthly IBR data from all contributing law enforcement agencies throughout Virginia on Group A and Group B Criminal Offenses, as established by the FBI. Virginia crime data, broken down by offenses and arrests by cities and counties statewide, is published annually in the "Crime In Virginia" report and made available via the VSP website. A monthly file of Virginia's data is also generated and emailed to the National Program for inclusion in the FBI's "Crime in the U.S." report.

**Virginia Criminal Information Network (VCIN)/National Crime Information Center (NCIC):** Serving 815 local, state and federal member agencies, VCIN/NCIC store information relating to wanted persons, missing persons, protective orders and stolen vehicles. Warrants and protective orders issued by Virginia magistrates are automatically entered into VCIN/NCIC via the Supreme Court of Virginia E-Magistrate Interface.

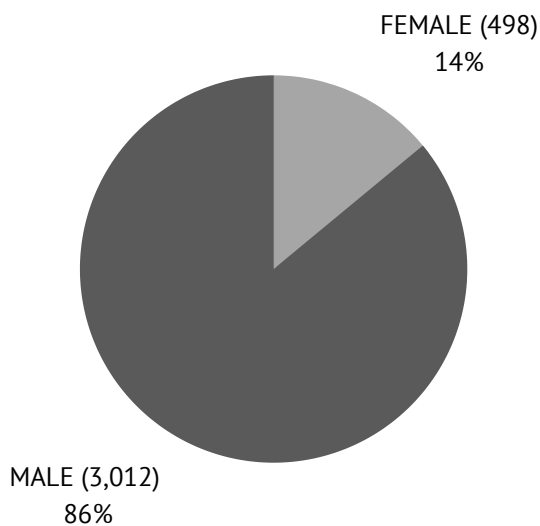

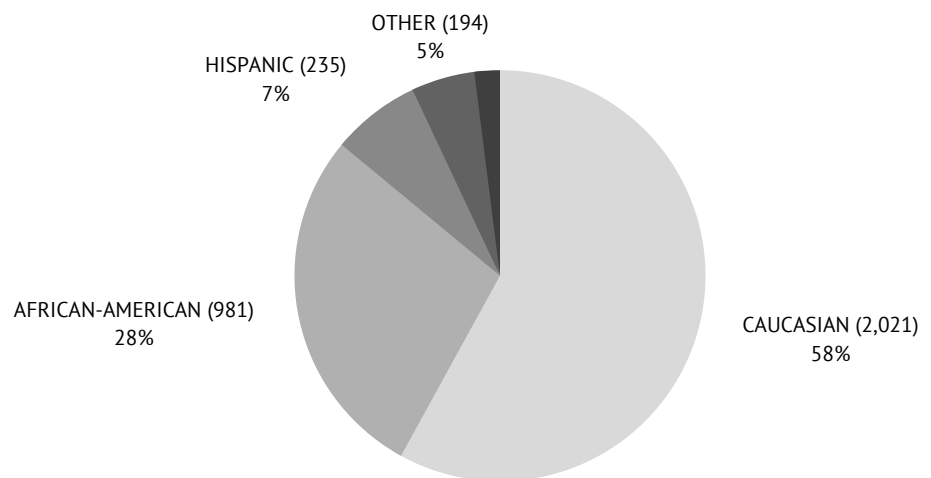

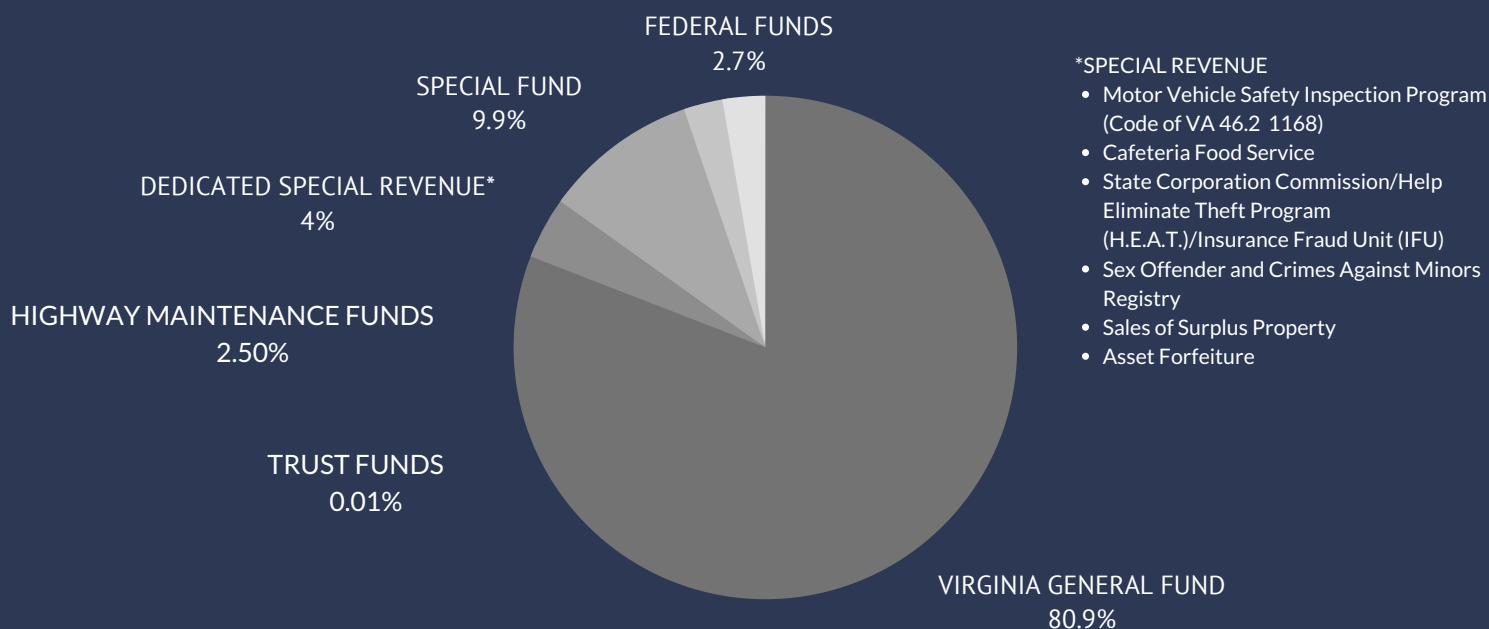

## PROPERTY AND FINANCE DIVISION

All financial reporting is prepared in compliance with applicable state and federal regulations, including but not limited to the Commonwealth Accounting Policies and Procedures (CAPP) Manual and the Financial Reporting Directive by the State Comptroller; and the Federal Office of Management and Budget (OMB) circulars for state and local governments. The Department works with the State Auditor of Accounts (APA) and all federal auditors.

Along with the Office of Performance Management and Internal Controls (OPMIC), the Division continually reviews policies and procedures to ensure agency compliance with the Virginia Department of Accounts's Agency Risk Management and Internal Controls Standards (ARMICS).

During FY2017, the Department:

- Billings from all sources totaled \$69 million, with collections from all sources totaling \$53.3 million for a June 2017 Accounts Receivable Balance of \$19,972,929.
- Maintained a Prompt Payment Act compliance rate of 96.91% on 36,801 total payments.
- Received \$28,242 in public assistance from the Federal Emergency Management Agency (FEMA) resulting from the Jan. 22, 2016 winter storm.
- Managed asset forfeiture accounting, in accordance with applicable state and federal guidelines and reporting requirements.

The Division oversees the property management and maintenance of 125 Department buildings and real estate across the Commonwealth.

In 2017, a new Target Firing Range and Tactical Indoor Firearms Training Facility were completed at the Driver Training Complex in Blackstone. A new building was also constructed to house the Help Eliminate Auto Theft (H.E.A.T.) Unit offices and vehicles.



Virginia Excess Military Property Program aided a total of 165 Virginia law enforcement agencies with procurement acquisitions of surplus military property and equipment via the U.S. Department of Defense.

The 1122 State and Local Law Enforcement Procurement Program allows state and local law enforcement agencies to purchase, at substantial savings, law enforcement equipment suitable for counter narcotic activities through federal procurement channels. In 2017, the Department purchased \$3.1 million worth of equipment for a net savings of \$338,484.

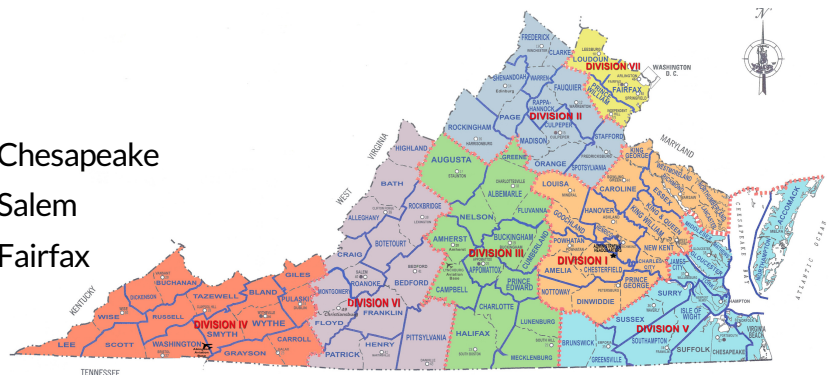


# BUREAU OF FIELD OPERATIONS (BFO)

Primary responsibility is patrolling the Commonwealth's more than 70,000 miles of interstate, primary, secondary, frontage, urban and rural highways. Uniformed BFO personnel provide both traffic and criminal law enforcement. Virginia's geography and size dictate the need to decentralize the Department's uniformed police services into seven field divisions. These divisions are further subdivided into 48 Areas that consist of one or more cities and/or counties. Staffing for each Area Office is based upon workload demands at the city and county levels.

**Crime Prevention Program:** Assists state and local law government, private entities, civic groups, schools and the citizens of Virginia with proactively reducing the incidence of crime within local communities, neighborhoods and businesses. In 2017, VSP Certified Crime Prevention Specialists dedicated approximately 3,906 personnel hours to 3,562 presentations that reached nearly 111,000 Virginians. The presentation topics focused on personal, traffic and/or workplace safety. State police Crime Prevention Specialists also conducted 435 Community Policing Through Environmental Design (CPTED) Security Assessments statewide.



# BUREAU OF FIELD OPERATIONS (BFO)

## AVIATION UNIT

Provides aircraft support for search, rescue, law enforcement and medical evacuation missions through three Aviation Bases located in Chesterfield County, City of Lynchburg and the Town of Abingdon. Established January 1, 1984, the Unit today is equipped with three Bell 407 helicopters, two Airbus EC145 helicopters, and three Cessna fixed-wing aircraft. The Unit's Trooper-Pilots are qualified "Police Pilots," and have commercial pilots' licenses. The Unit employs three full-time mechanics for its fleet and exceeds minimum FAA maintenance requirements.

**Med-Flight/Medevac:** Operates from the Chesterfield and Abingdon Aviation Bases with operation costs shared with the Virginia Commonwealth University (VCU) Medical Center, Chesterfield County Fire and EMS, Wellmont Health Systems, Colonial Heights Fire and Rescue, Henrico County Fire and Rescue, and the City of Bristol, Virginia Police Department. In 2017, the two Med-Flight programs transported a total 756 patients.

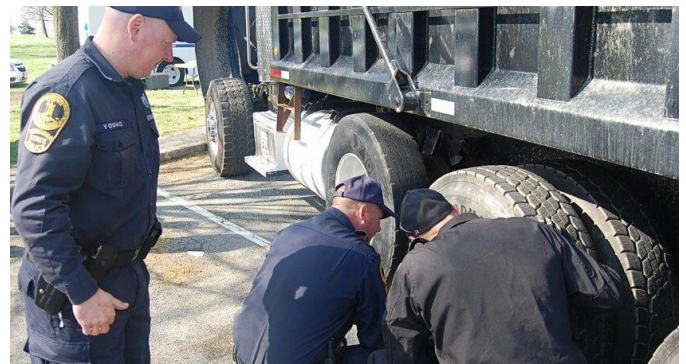

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

Provides thorough and comprehensive investigations of all criminal matters mandated by Virginia statute and intelligence support relative to criminal activity in the Commonwealth.

The statutory mandates include the investigation of

- Any matter referred by the Governor;
- Requests by the Attorney General, commonwealth's attorneys, chiefs of police, sheriffs and grand juries of matters that constitute Class 1, 2, or 3 felonies;
- Elected officials when directed by the Governor, Attorney General or grand juries.

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

## BCI FIELD OFFICE - DRUG ENFORCEMENT SECTION (DES)

Provides full-time attention to the enforcement of drug laws in Virginia, and is committed to supporting local law enforcement agencies in their efforts. DES has in excess of 100 special agents across the Commonwealth responsible for performing operational narcotics enforcement investigations, including special undercover, wire intercept and marijuana eradication efforts. DES actively participates or is directly responsible for 53 multi-jurisdictional drug and gang task forces representing 120 jurisdictions in Virginia. DES also routinely assists with federal and local narcotics investigations.

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

## CRIMINAL INTELLIGENCE DIVISION (CID)

Provides analytical and research support to local, state, and federal law enforcement agencies on matters pertaining to the Commonwealth of Virginia through the identification, documentation and dissemination of criminal intelligence concerning persons involved in organized crime, terrorist groups and those crimes involving multi-jurisdictional or serial crimes.

**Field Intelligence Unit:** Operates to improve intelligence collection and dissemination, to gather tactical intelligence in support of criminal investigations, and to use intelligence in support of strategic planning through strong liaison and interaction with department personnel and local law enforcement counterparts.

**Joint Terrorism Task Force (JTTF):** Coordinated through the FBI, VSP CID personnel are assigned to the the JTTF Task Forces in Virginia for the purpose of pursuing criminal leads, gathering evidence, making arrests, providing security for special events, collect and share intelligence, and respond to threats and incidents. In 2017, the JTTF was responsible for the multiple FBI arrests resulting from the August 12, 2017 Unite the Right Rally in Charlottesville.

**Virginia Fusion Center (VFC):** Formed in 2005, the VFC is a joint operation between VSP and the Virginia Department of Emergency Management (VDEM) to focus on counter-terrorism intelligence investigations and analysis. VFC is occupied by local, state, and federal law enforcement agencies, public safety, emergency management, and/or the military in prevention of, or in response to, an incident. It maintains liaison with representatives from partnering agencies in order to facilitate and ensure communication between the Virginia State Police and those agencies, allowing for a more coordinated, informed response.

**Fusion Liaison Training Program:** Continues to grow and succeed in information to both the public and private sectors in order to enhance the safety of Virginia citizens. Topics include personal safety in places of worship, civilian response to an active shooter and suspicious activity recognition and reporting.

**Northern Virginia - Washington D.C. Internet Crimes Against Children (ICAC) Task Force:** Counters society's rapid explosion of online child exploitation, pornography and predators through its 52 local, state and federal partnering agencies. Established in November 2004 through a grant from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP), VSP serves as the coordinating agency. The grant provides for law enforcement training and equipment, and for conducting online investigations.

**Technical Support Section:** Supports significant investigations and uses sophisticated methods and technologies to assist any requesting law enforcement agency. The Hostage/Barricade Response Program was developed in 1997 to support federal, state and local law enforcement through the deployment of technical equipment and personnel resources.

# BUREAU OF CRIMINAL INVESTIGATION (BCI)

## COUNTER-TERRORISM AND CRIMINAL INTERDICTION UNIT (CCI)

Established to suppress criminal activity with specific emphasis on reducing the flow of illegal narcotics on Virginia highways, public transportation systems, schools and parcel distribution businesses. CCI also partners with the multi-agency, multi-state High Intensity Drug Trafficking Areas (HIDTA) established throughout the Commonwealth in relation to analytical data concerning opioid overdose incidents, drug identity, reported drug packaging trends, and drug threat reports. CCI personnel are equipped and specially-trained to provide seven regional response teams to address chemical, nuclear and bio-terrorism events.

## HELP ELIMINATE AUTO THEFT (H.E.A.T.) PROGRAM

2017 marked HEAT's 25th anniversary since being established by the Virginia General Assembly in 1992. The program educates citizens about theft of vehicles and their parts, a crime that costs Virginians millions of dollars each year. HEAT also trains and supports local law enforcement officers in efforts to prevent auto theft. The HEAT program is a cooperative effort of VSP, Virginia Department of Motor Vehicles (DMV) and local law enforcement agencies throughout the Commonwealth.

## INSURANCE FRAUD PROGRAM (IFP)

Established in 1999, the IFP works to Stamp Out Fraud by providing training to law enforcement and teaching citizens how to identify and report insurance fraud. Insurance fraud is any act committed with the intent to obtain benefits or advantages where they are not entitled, usually through a sum of money. Insurance fraud costs American consumers more than \$80 billion dollars each year. Three common categories of insurance fraud are property fraud, casualty fraud and workers' compensation fraud.
