2. Data Requirements

DATA SOURCES	Database extract of Incident Based Reporting (IBR), Community Policing Act (CPA) and Automated License Plate Reader (ALPR) data provided by vendor contracted with the law enforcement agency to be entered in provided form. Vendor must provide the data as indicated in the content requirements.
DATA COLLECTION METHOD	Quarterly completion of an online Microsoft form and data extracted from Virginia Crime Repository based on content requirements below. Form entry must be submitted by the Law Enforcement Agency.
DATA UPDATE FREQUENCY	Quarterly; Q1 (January - March) Due April 1; Q2 (April - June): Due July 1, Q3 (July - September): Due October 1, Q4 (October - December): Due January 1
